

Declaration of consent for the exercise of airsoft games on my property

Between

Georg Hamelmann
Tactical Recon Squad

- hereinafter referred to as lessee -

and the player listed in the appendix

I hereby grant permission to the player to play airsoft games on the Green Mile property at the conditions set forth in this Declaration of Consent.

§ 1 Use of the site

1. The property is in my / and is completely pacified (privately owned).
2. In order not to harm uninvolved persons, the player must ensure that the airsoft balls can not leave the area. For this purpose, designated protection zones must be observed
3. The terrain is provided to the player for a small lease.
4. The following costs may arise
 - Usage costs 15 €
 - Safety vest 3 € (only if the player has no own)
 - Teampatch (red / blue) 5 € (only if the player does not have his own)
5. For the duration of this agreement, the player is subject to the farmer's house right and he must be obeyed. If you break the house right so the tenant is entitled to refer the player from the area

§ 2 Code of Conduct

1. For reasons of environmental protection may be shot on the entire property only with biodegradable Airsoftkugeln (so-called BB's).
2. The use of pyrotechnic products, such as bang, Blend and smoke body not allowed
3. The prescribed team patches are to be worn at all times. And have to be brought back to the end of the game. Otherwise deposit will be forfeited
4. Each player is required to wear a safety vest. Who does not carry with you is obliged to buy a safety vest from the Orga Team. No exceptions are made here.
5. Open fire / smoking and grilling is only allowed in assigned places. Fire protection regulations must be observed!
6. Packaging of self-brought food and drinks as well as packaging of accessories and other things (such as empty gas and / or CO₂ cartridges) are collected by the players again independently and to be disposed of properly.
7. To protect the neighborhood, legal rest periods must be observed. Games at lunchtime are to minimize to a tolerable level of noise. From 22:00 o'clock the game operation is to be stopped (night rest)
8. Urinating or worse may not be done on the field. There are toilets available at the entrance. Should anyone be caught doing this, it will be immediately removed from the square
9. On and off the field is strictly prohibited alcohol. In case of violation, player is immediately expelled from the field.

§ 3 Liability / warranty

1. The tenant of the property is not liable for any damage to the equipment or the weapons. The same applies to injuries of the respective player.
2. The Tenant of the property is not liable for the loss of private property
3. Each player enters the property at his own risk and has to take care for a suitable insurance protection itself.
4. Damage to existing buildings or inventory must be reported immediately. In the case of unreported damages incurred during a match, the team/ Player will be held liable
5. In the case of regulatory or police control, the team shall be designated as responsible.
6. a In case of improper behavior of the team and the resulting incorrect operations of the authorities (fire brigade, police) the costs for the misuse of the team/Player are to be borne.

§ 4 Legal provisions

1. The statutory provisions, in particular the currently valid weapons law of the Federal Republic of Germany, are to be observed.
2. The state laws and ordinances of the respective federal state, in which the property is located and the airsoft game is played, are also to be observed.
3. All equipment, attachments and performance enhancements of airsoft guns that violate applicable law are prohibited.
4. In Germany, not approved bang, Blend and smoke body, unless otherwise agreed under § 2, item 2, are not allowed and may not be used under any circumstances.

§ 5 Duration of the agreement

1. This Agreement is initially closed, including at _____.
2. If no date is specified under § 5, point 1, this agreement applies until further notice.

§ 6 Termination of this agreement

3. Each contracting party is entitled to terminate this declaration of consent for good cause with immediate effect - in whole or in part.
4. Further mutual claims are excluded.

§ 7 Changes / invalidity

For changes and additions as well as ancillary agreements written form is required. Should any provision of this contract become invalid, this shall not affect the validity of the remaining provisions.

§ 8th Come into effect

This agreement comes into effect upon signing by the player.

§ 3 Haftung / Gewährleistung

1. Der Pächter des Grundstücks haftet nicht für evtl. Schäden an der Ausrüstung oder an den Waffen. Gleiches gilt bei Verletzungen der jeweiligen Spieler.
2. Der Pächter des Grundstücks haftet nicht für evtl. Verlust von Privatsachen.
3. Jeder Spieler betritt das Grundstück auf eigene Gefahr und hat für einen geeigneten Versicherungsschutz selber Vorsorge zu tragen.
4. Beschädigungen an bestehenden Gebäuden oder Inventar sind unverzüglich zu melden. Bei nicht gemeldeten Schäden, die bei einem Spiel entstanden sind, wird das Team dafür in Haftung genommen (nach Absprachen mit dem Eigentümer kann dieser Passus angepasst oder gestrichen werden).
5. Bei einer ordnungsbehördlichen, oder polizeilichen Kontrolle ist das Team als Verantwortlicher zu nennen.
6. Bei unsachgemäßem Verhalten des Teams und daraus resultierenden Fehleinsätzen der Behörden (Feuerwehr, Polizei) sind die Kosten für den Fehleinsatz von dem Team zu tragen.

§ 4 Gesetzliche Bestimmungen

1. Die gesetzlichen Bestimmungen, insbesondere das zurzeit gültige Waffengesetz der Bundesrepublik Deutschland, sind zu beachten.
2. Die Landesgesetze und Verordnungen des jeweiligen Bundeslandes, in dem sich das Grundstück befindet und das Airsoftspiel ausgetragen wird, sind ebenfalls zu beachten.
3. Sämtliche Geräte, Anbauteile und Leistungssteigerungen der Airsoftwaffen, die gegen das geltende Recht verstößen, sind verboten.
4. In Deutschland nicht zugelassene Knall-, Blend- und Rauchkörper, soweit unter § 2, Punkt 2 nicht anders vereinbart, sind nicht erlaubt und dürfen auf keinen Fall eingesetzt werden.

§ 5 Dauer der Vereinbarung

1. Diese Vereinbarung wird zunächst einschließlich zum _____ geschlossen.
2. Wird unter § 5, Punkt 1 kein Datum angegeben, gilt diese Vereinbarung bis auf Widerruf.

§ 6 Beendigung dieser Vereinbarung

1. Jeder Vertragspartner ist berechtigt, diese Einverständniserklärung aus wichtigem Grund mit sofortiger Wirkung - ganz oder teilweise - zu kündigen.
2. Weitere gegenseitige Ansprüche sind ausgeschlossen.

§ 7 Änderungen/Unwirksamkeit

Für Änderungen und Ergänzungen sowie Nebenabreden ist die Schriftform erforderlich. Sollte eine Bestimmung dieses Vertrages ungültig werden, so berührt dies die Gültigkeit der übrigen Bestimmungen nicht.

§ 8 Inkrafttreten

Diese Vereinbarung tritt mit Unterzeichnung des Spielers in Kraft.
